By car

1. Follow Den Haag on the A12 until the traffic lights

2.Turn left on to Zuid Hollandlaan

3. Turn left on to Koningskade and immediately right on to Korte Voorhout

4. After 300 meter, turn right on to Lange Voorhout

5. After 150 meter, turn left to continue on Lange Voorhout

6. Turn the next right on to Parkstraat

7.At the end of the street, turn left on to Mauritskade

8. Take the next right on to Zeestraat and immediately left on to Kortenaerkade

9. The ISS is the first building on your right

NB: There is paid parking only in the vicinity of ISS during these hours: Monday-Saturday 09:00-24:00 and Sunday 13:00-24:00
